## RULES OF THE COMPETITIONS ARE AS FOLLOWS:-

FINALS weekend will be 22<sup>nd</sup>, 23<sup>rd</sup> August 2026 from 11am

- a) Members reaching competition finals must be available to play on both days of the “FINALS WEEKEND” as this is the date set aside in the club calendar especially for that purpose and to enable the competitions secretary to schedule the matches.  
**Please don't enter if you are not available on “FINALS WEEKEND”, except if you are playing a National Final at Leamington.**
- b) In the case of substitutes, National Rules will apply.
  1. Arrangement of Matches. The challenger(s) will be the first named participant indicated on the draw list displayed on the Club notice board. It is the responsibility of the challenger to arrange each match.
  2. The challenger(s) is to offer dates and times on which the match could be played to the opponent(s). The opponent(s) should endeavour to accept one of the offered dates, but if none of the dates are acceptable, both should attempt to arrive at a compromise date. If a compromise date cannot be played by the due date, then both competitors should approach the Competitions Secretary, to resolve the situation. There may be instances where a resolution is not possible in which case the challenger will progress to the next round. Please note: Weekday mornings up to 11.30 a.m. should not be offered **without the prior permission of the green keeper** to facilitate the cutting of the green
  3. Although it is the responsibility of the challenger to arrange a game, in the event that no challenge is made, the opponent should make every effort to contact the challenger.
  4. It is the responsibility of the challenger to provide a marker for singles matches.
  5. A copy of these rules can be found on the Club notice board.
